Post Box: On the Post Box at the corner of Pekanga/Normandale Road was a small notice advising the Postal box was to be removed and for use to made of the Box at 52 Normandale Road. Alas there is no Post Box at 52 – perhaps 152 N'dale Rd., was what was meant? Margaret had emailed various people including Katrina Shanks who said she'd look into the problem. Margaret suggested that as the NRA we could write to N.Z.Post and set out the situation. All agreed. **Margaret will draft a letter.**

Western Ward Committee: will write to the NRA, along with other residents Associations, soon asking for ideas for community planning. Ideas relevant to the area that the ward committee can do something about are welcome.

- Suggestion develop a formed path across the western hills. As well as a good path to walk or run on this could be very useful in times of earthquakes as there is no road right across the top of the hills.
- Development ideas for the playgrounds. Pete also needs to speak with Bruce HCC about Poto Road
- The Scout Hall what is it used for, who owns it what could it be used for instead of rotting away as it is now?

Inorganic Rubbish Collection: first Earthlink/ then McAuleys metal truck/ finally the rubbish truck. Need 10 - 12 volunteers. **Margaret will check** if trucks are available in mid-November. The Global Volunteers are no longer operating.

Rhododendrons and Azaleas: Planting on August 8th. Pete suggested inter-planting with ringa ringa. Grant suggested blecknum. **Pete will discuss options with Suzy**.

Regional Council Public Transport Plan: Pete will prepare a comment on our behalf. **Margaret will send Pete** some information re the <u>Regional Public Transport Strategy</u>. This to express support for the bus service we receive which we wish to continue as is. To express real concern over the suggestion of losing the Melling line and to comment on lateness/odd changes to train/bus service and the unsatisfactory mess this has been recently - particularly as the notices of changes have not been in obvious places where people would see them. To point out how helpful integrated servicing would be.

Clean Up N.Z. Week. $20^{th} - 27^{th}$ August. Grant will organise bags and the day chosen will be Saturday 20^{th} August. An advertisement needs to go into the N'Times re this with time and meeting place. Part of the Keep Hutt City Beautiful campaign.
